- 3. Interested Contractors should do an e-payment of Rs.6000/- towards Tender Processing Fee. The Tender Processing Fee is non-refundable.
- 4. Interested Contractors should submit Earnest Money Deposit (EMD) of Rs.79,000/-through e-payment mode as mentioned in tender document.

5. Minimum pre-qualification criteria

An individual or Registered Firm or a LLP or a Company having Goa PWD registration or equivalent registration in MES, CPWD in the category electrical class II or higher class of Goa PWD as per new regime with an upper limit of qualification to quote for works amounting to Rs.50 lakhs and equivalent eligibility as per CPWD or MES.

The interested contractors shall submit hard copy of the following to EDC Ltd. by 3.30 p.m. on 08/05/2023.

- (a) Certified copies of experience Certificate/ Bills/ Work order, registration certificates, etc. of the Contractor to prove their prequalification as per following Minimum Pre-qualification criteria.
- (b) Attested copy of ownership documents, Pan Card/ GST registration Certificate.

The above documents shall be placed in a single envelop super scribed as "Technical Bid".
